



**TROPHY HUNTING AND SAFARI AGREEMENT
MEMORANDUM OF AGREEMENT ENTERED INTO BETWEEN**

WHEREAS the CLIENT wishes to engage in a Trophy Hunting Safari at FARM VERONICA and/or FARM KALAKWA in the District of, Windhoek, for a period of _____ hunting days from _____ to _____

AND WHEREAS the CLIENT and ARU have agreed to conclude such Hunting Safari Contract on the undermentioned terms and conditions.

NOW THEREFORE the **CLIENT** and **ARU** hereby agree with each other as follows:

1. TERMS OF PAYMENT

- 1.1 All prices are quoted and are payable in Euro/US Dollars;
- 1.2 A deposit of 50%, based on the daily rate is payable on confirmation of the booking;
- 1.3 The balance of the daily rate, plus trophy fees for animals hunted and any animals wounded and lost, will be determined and calculated at the end of the safari and will then be payable;
- 1.4 Deposit will only be refunded if client cancels the safari within 30 (thirty) days after date of confirmation of booking, subject to a 15% administration fee and provided the cancellation is done at least 90 (ninety) days prior to date of commencement of safari.
- 1.5 All prices and charges are subject to change;
- 1.6 All payments must be made in cash.

2. SAFETY PRECAUTIONS

- 2.1 Guns will be tested on the shooting range before hunting commences;
- 2.2 No shooting from vehicles in movement will be allowed unless specifically requested;
- 2.3 Shots will only be fired after acknowledgement or order from professional hunting guide has been received;
- 2.4 Guns must be safe at all times.

3. **PRICES QUOTED ARE INCLUSIVE OF:**

- 3.1 Hunting License Fees;
- 3.2 All pre-hunt preparations and any Leopard baiting (if applicable);
- 3.3 The services of hunting guide, trackers, skimmers and driver;
- 3.4 Four-wheel-drive hunting vehicle;
- 3.5 Field preparation of trophies and delivery to local taxidermist;
- 3.6 Luxurious accommodation at ARU GAME LODGES on either FARM VERONICA and/or KALAKWA;
- 3.7 All meals and beverages;
- 3.8 Transport by road to and from Hosea Kutako International Airport, Windhoek;
- 3.9 Daily cleaning and laundry service;
- 3.10 Game drives;
- 3.11 VAT on daily accommodation rates and fees.

4. **PRICES QUOTED ARE EXCLUSIVE OF:**

- 4.1 Transport costs from abroad to Hosea Kutako International Airport, Windhoek and back, and Airport Taxes;
- 4.2 Optional travel by aircraft from Hosea Kutako International Airport, Windhoek to any other destination in Namibia or elsewhere and back;
- 4.3 International phone calls and faxes;
- 4.4 Insurance and medical expenses of any kind;
- 4.5 Taxidermist fees and the shipping of trophies;
- 4.6 Import permits and fees required by countries other than Namibia;
- 4.7 Gratuities to lodge staff;
- 4.8 Trophy fees for game wounded or taken and lost;
- 4.9 Accommodation expenses before and after the scheduled trophy hunting period.
- 4.10 Sight seeing excursions other than on the properties operated by **ARU GAME LODGES**;

5. **INDEMNITY FROM LIABILITY**

- 5.1 Whilst every care and precaution is taken to ensure the safety of the **CLIENT**, it is noted that any hunting safari is potentially hazardous;
- 5.2 The **CLIENT** hereby indemnifies **ARU** or its successors in title, its staff and all of its associate companies, organizations, or persons acting for, or on its behalf, against any loss or damage, whether caused directly or indirectly by delays, sickness, injury, death, or loss or damage to property, whether occurred by negligence or not, or any expenses arising therefrom, which the **CLIENT** may suffer while on safari at VERONICA or KALAKWA or while under its custody or control and the client undertakes to sign an indemnity in the form annexed hereto as Annexure "A";
- 5.3 Neither **ARU** nor its successors in title, its staff and all of its associate companies, organizations, or persons acting for, or on its behalf, shall be responsible for the loss or damage arising from any errors or omissions, contained in this contract or any other literature;
- 5.4 Should the **CLIENT** so elect, he may obtain the necessary comprehensive insurance before arriving for the Hunting Safari, which insurance should cover damages suffered as a result of cancellations, medical expenses and protection of personal property and money. It is recorded that the onus of insurance (although optional) rests on the **CLIENT**, and that **ARU** or its successors in title, its staff and all its associate companies, organizations or persons acting for, or on its behalf is rendered harmless in that respect.
- 5.5 Although VERONICA AND KALAKWA is not situated in a primary malarial area, the **CLIENT** hereby indemnifies or **ARU** or its successors in title, its staff and all of its associate companies, organizations, or persons acting for, or on its behalf, against any loss or damage resulting from the possible contraction of malaria by the **CLIENT**.

6. **GENERAL**

- 6.1 The **CLIENT** agrees that photographs and videos taken during the safari may be used for promotion and/or publicity purposes by **ARU**;
- 6.2 **ARU** may, at its discretion and without liability or cost to itself, at any time cancel or terminate a **CLIENT'S** Safari and in particular, without limiting the generality of the foregoing, it shall be entitled to do so in the event of illness or the illegal or incompatible behaviour of the **CLIENT** undertaking the Safari, who shall in such circumstances not be entitled to any refund;
- 6.3 Any indulgence granted by **ARU** will not be interpreted as a waiver of its rights in terms of this contract;
- 6.4 The **CLIENT** undertakes to complete a client information sheet in the form as annexed hereto marked Annexure "B" and **ARU** is hereby indemnified should **ARU bona fide** act upon any information by the client upon such sheet.
- 6.5 This contract has been drawn and will be interpreted in terms of Namibian Law.
- 6.6 Prior to departure the **CLIENT** shall complete and sign a trophy and shipping instruction and hunting register form in format as Annexure "C" and "D" hereto.

I hereby **Waive (waive)** all claim or claims of whatsoever cause or nature however arising against the owners of **ARU GAME LODGES**, their successors in title, their associates, servants, employees and / or any persons connected whether directly or indirectly with the running of **ARU GAME LODGES** and fellow guest / invitees which I might have arising out of harm, injury, death, or loss suffered whilst on the premises or properties operated by **ARU GAME LODGES** whether arising from an act of commission or omission on the part of those hereby indemnified or any one of them.

I further Indemnify and hold harmless and free, the owners of **ARU GAME LODGES**, their successors in title, their associates, servants and the employees and / or any persons connected whether directly or indirectly with the running of any of the lodges and fellow guest / invitees from any and all claims of whatsoever cause or nature which may arise on behalf of my spouse, common law wife / husband, my children, whether minor or adult, or relatives and / or persons accompanying me to any of the properties operated by **ARU GAME LODGES** whether as my invitee or otherwise or at all who suffer injury or loss whilst on the premises or any of the properties operated by **ARU GAME LODGES** and whether arising from an act of commission or omission on the part of those hereby indemnified or anyone of them.

In the event of injury, **ARU GAME LODGES (PTY) LTD** may as its discretion and without prejudice and without admission of liability arrange and pay for emergency medical treatment for and on behalf of any guest.
